

# True All City Championship

## Rochester, Minnesota

### 2021

#### **Congratulations!**

Receiving this communication signifies that you have been selected for, and are officially and formally invited to participate in the third annual True All City Championship (TACC).

#### **Dates**

- The TACC will occur on and between the dates of **April 14th, 2021 and October 3rd, 2021.**

#### **Cost**

- There will be **no cost to enter** the championship. However, any fees charged by the various courses (green fees, cart fees, and/or food and beverage costs) will be the responsibility of the participant.

#### **Requirements and Rules**

- Complete a round of golf at each of the 4 golf courses that are run and operated by the city of Rochester, Minnesota. These rounds need to be completed between the dates of April 14<sup>th</sup> and October 3<sup>rd</sup> of the year of our Lord 2021:
  - Eastwood Golf Course (18 holes)
  - Northern Hills Golf Course (18 holes)
  - Soldiers Memorial Field Golf Course (18 holes)
  - Hadley Creek Golf Course (9 holes)
- Each round of golf will be stroke play without handicaps and in accordance with USGA rules.
- All participants will be required to declare, before playing, when they are beginning a portion of the TACC competition (verbally with a witness or via text/email with Christopher Hilker). Undeclared rounds will not be considered for TACC scoring. After a declared round or declared partial round is completed, an image of the score card (signed and dated) should be sent to Christopher Hilker. Failure to do so in a timely manner may result in disqualification per the tournament committee's discretion.
  - Note, participants may be asked to appear before the tournament committee for questioning to assess personal character and trustworthiness. Character witnesses may also be called for questioning.
- You are encouraged to play with a witness or another TACC participant, but this will not be required. A witness should be asked to sign and date the official score card and may be asked to testify before the tournament committee on the player's behalf for the authentication of the score.
- If rain, weather, darkness, disease, unrelenting bowels or another unforeseeable event prevents the completion of a declared TACC round, the partial score card should be sent to Christopher Hilker. The participant should finish the round at their convenience and follow round declaration and submission procedures. Scoring will be for only the remaining holes of the previously suspended TACC round.
- Order of Play:
  - Courses may be played in any order.
  - Holes may also be played in any order (with clubhouse approval) and with the stipulation that

each hole is scored only once for the TACC. The 18 or 9 different holes composing each course should be played once each for the TACC.

- Participants are free to play any or all holes prior to starting any of their TACC rounds or completing previously started and delayed rounds. However, the declared start of TACC play and receipt of the score card will be monitored to help discourage dishonesty.
- Playing all holes on a course at one time is encouraged, but not required.
- Declaring the start of a TACC round is allowed once per round at any point before a hole is started.
  - If this occurs mid-round, A witness is recommended, but text messages are acceptable or a complete video documentary of the proceedings.
- Ending a TACC round is allowed at any point after a hole is completed. This is done with a verbal or text declaration of cessation of TACC play.
  - A witness is recommended, but text messages are acceptable or a complete video documentary of the proceedings.
- After a TACC round is ended and, the participant is not allowed to re-declare and begin TACC play during that round. A player must exit the golf course property and secure a new tee time or approval of play with the clubhouse to begin TACC play again.
- Repeating a hole or a shot for practice is not allowed during TACC declared play.

## Awards and Prizes

- Prizes will be awarded for each course's best score as well as various other prizes the tournament committee sees fit (Current Prize list below). You are welcome to petition the tournament committee with suggestions. A mailing address will be provided for this at a later date.
  - Medal for overall TACC champion with privileges
  - Medals for each course champion with privileges
  - 12 ounce Busch Light\* for a birdie
  - Six pack Busch Light for an eagle
  - One Natural Light "Naturday" strawberry-lemonade beer\* for a Skin
  - One "Aloha Beaches" Natural Light Seltzer\* for a recorded up and down out of a bunker.  
(note, this does not need to be for par or better)
- \*If for an unforeseeable reason any of these beverages become unavailable, a suitable replacement will be made at the discretion of the TACC committee.
- The participant with the lowest 63 hole total over all 4 city courses will be named the Champion of the 2021 TACC and be awarded a medal and privileges.
  - In the event of a tie, a random number between 1 and 18 will be selected which will indicate a hole number. The total score for that hole on all 4 courses will be added together for each of the tied participants. The lowest score will be declared the winner. Hadley Creek holes 1-9 scores will also represent Hadley Creek 10-18 for this purpose, but will not be counted as part of the 63 hole total.
  - The process of selecting a hole at random and summing the scores for each tied player will be repeated as necessary to identify a winner.
  - In the unlikely event that a tie occurred because both (or multiple) players scored exactly the same on each hole, then a dual (or multi) champion will be declared.
- To qualify for any and all prizes, you must complete the 63 holes before October 4<sup>th</sup>, 2021.

## Unforeseeable Events

- If circumstances come into play where it is not possible to complete the 2021 TACC, the TACC

committee will decide on how to best proceed. Options may include, but are not limited to: shortening the tournament, altering course play and/or cancelling the 2021 Championship.

## **Legal**

- The tournament committee reserves the right to disqualify and shame any participants per the committee's discretion.
- All decisions from the TACC committee are final, but subject to amendment at the discretion of the TACC organization and affiliates.
- Any and all participation in the 2021 TACC is an acknowledgement that you release Christopher Andrew Hilker, the TACC organization, committee and affiliates of any and all forms of liability for any claims, demands, damages, actions, causes of action or suits of any kind or nature whatsoever, which now have or may hereafter have, arising out of or in any way relating to any and all injuries and damages of any and every kind to both person and property, and also all injuries and damages that may develop in the future as a result of or in any way relating to the 2021 TACC.
